PLAYER REWARDS PROGRAM

| TERMS AND CONDITIONS |

TO BECOME A MEMBER

- a. Membership is complimentary to guests 19 years of age or older
- b. An application is available at any participating Playtime Community Gaming Centres Inc. ("Playtime") facility
- c. Applications must be completed in full and submitted with a government-issued photo ID as proof of age
- d. Approved applicants will receive a card which will be accepted at participating Playtime facilities
- e. Playtime reserves the right to deny membership if an individual is excluded from a Playtime facility through the self exclusion program or at Playtime's sole discretion
- f. Playtime employees and their immediate family members and members of their households are not eligible to participate

POINTS & VALUE

- a. Points are awarded at the time an active card is swiped
- b. The card may only be swiped by the member to a maximum of four (4) times daily.
- c. Each swipe is valued at one hundred (100) points
- d. Points are awarded to individual member accounts only and may not be combined with, or transferred between, other accounts
- e. All points earned are subject to review and verification by Playtime whose determination is final
- f. Playtime reserves the right to adjust account balances due to computer error, machine malfunction, operator error, fraud or misuse of the card or to correct accounting errors

POINT REDEMPTION

- a. \$5 Cash-Back for every 5,000 points
- b. Members may begin requesting Cash-Back after 5000 points or more have accumulated and may only redeem in increments of 5000 points
- c. Card holders must demonstrate membership via valid government issued photo ID and sign a redemption form to redeem points and receive Cash-Back
- d. Points may be redeemed at the sales counter of any participating Playtime facility
- e. Points have no monetary value until redeemed and cannot be negotiated
- f. Cash-Back cannot be used to purchase liquor or tobacco products at a Playtime facility

PRIVACY

- a. It is a condition of membership that the member provide the personal information on the application form
- b. The member consents to Playtime using the personal information to provide services to the member, including awarding points, and for communicating with the member, including conducting surveys and providing information about products and services that may be of interest to the member
- c. Members may opt out of receiving additional program & promotional communications by returning the card to any Playtime facility and requesting cancellation from the Program

OTHER CONDITIONS

- a. Playtime reserves the right to change the terms and conditions, program features and benefits, redemption procedures, membership criteria, change or cancel points and rewards, terminate the program, all without notice or compensation even though the value and number of points accumulated may be affected
- b. Member accounts that have been inactive for a period of nine (9) calendar months will be considered abandoned, and membership will be terminated with any unredeemed points forfeited
- c. Members who request the cancellation of their card will forfeit any points that do not meet the redemption value as set forth in section 3
- d. Use of the card constitutes full and complete acceptance of the terms and conditions as stated herein or amended from time to time
- e. Cards are non-transferable and remain the property of Playtime and must be returned to Playtime upon request
- f. Cards should be treated like cash
- g. Playtime reserves the right to revoke membership for the failure to abide by the terms and conditions, any conduct detrimental to Playtime or the program or for any misrepresentation or fraudulent activities without notice and without compensation and in such case all accumulated points will be forfeited
- h. The facility and Playtime are not responsible for lost, misdirected, stolen, destroyed, or damaged cards or unauthorized use of a card or a member's points
- i. The British Columbia Lottery Corporation is not affiliated with the program
